SUBJECT: Tactical Combat Casualty Care Policy and Guidance

- 1. The Defense Health Agency (DHA) TCCC curriculum for Combat Medics, Hospital Corpsmen, and Aerospace Medicine Technicians was developed by subject matter experts from across the Department of Defense serving on a work group chartered under the Office of the Assistant Secretary of Defense for Health Affairs (OASD(HA)). It complies with the DoD requirement for all Service members to receive role based TCCC training and certification in accordance with their skill-level, as outlined in DoD Instruction 1322.24, "Medical Readiness Training," dated March 16, 2018. Effective immediately, this memorandum establishes Tactical Combat Casualty Care (TCCC) policy and training guidance for the Air Force Medical Service (AFMS). This guidance supersedes the AFMS TCCC Combat Lifesaver (Tier 2) Policy Memo dated 19 Aug 2021.
- 2. Commanders will ensure Regular and Air Reserve Component personnel receive this role based TCCC training and certification. Department of Defense service members and expeditionary civilians will conduct initial TCCC training and certification prior to deployment. Below is a synopsis of personnel aligned with their role based TCCC Tier:
 - a. TCCC ASM/Tier 1 Line of Air Force personnel
 - b. TCCC CLS/Tier 2 AFMS personnel not assigned to Tier3 or Tier 4 and personnel designated by the Training Matrix
 - c. TCCC CMC-AMT/Tier 3 Medical Technicians and personnel designated by the Training Matrix
 - d. TCCC MP/P/Tier 4 Physicians, PAs, NPs and IDMTs. Personnel who require TCCC
